



























All Hallows High School, the Bronx





Our Scholarships

BE A STUDENT'S FRIEND matches
Catholic school students in need of
financial assistance with a sponsor who
provides support. Sponsors can choose
to get to know their student personally or
remain anonymous and receive periodic
updates from their students.

THE CARDINAL'S SCHOLARSHIP & HIGH SCHOOL AWARD PROGRAMS

provides tuition assistance to families who transfer their children from a public elementary school to a Catholic elementary school within the Archdiocese of New York. The amount awarded in each scholarship is based on individual family needs, as well as on the tuition of the desired school and is renewable through high school graduation.

EMERGENCY TUITION ASSISTANCE

awards a one-time grant to families experiencing unforeseen financial hardship. This program enables students to remain in their Catholic school, which is often the most stable environment they know during turbulent times.

MERIT-BASED SCHOLARSHIPS

AND GRANTS are donor-designated awards that play a vital role in helping Catholic schools retain high-achieving inner-city students. Students receive awards based on their service to their community, academic excellence, and a number of other donor-designated factors.

In New York City, there are countless ways to define success. But the track to get there is rarely as straightforward as the Manhattan grid system, especially for a young person growing up in poverty. A city built on dreams can easily become a labyrinth, every setback proving that New York's perennial promise of a brighter future is meant for someone else. But even in the poorest neighborhoods, there is a chance to change course. Catholic schools are that chance.

When we look at what makes Catholic schools successful, we see strength in numbers. The cost to educate, graduation rates, matriculation to college: all of it adds up to a system that works. A Catholic school education is driven by exacting standards, but it is also rooted in values. I believe that this idea – the pursuit of a higher purpose – is the chief motivating factor in any mission to succeed. As our students graduate with the goal of leading purposeful lives in their communities, a successful Catholic school produces a winning outcome for everyone.

We have an aspiration at Inner-City Scholarship Fund as well. In September 2015, we launched our \$125 million kids Are Our Capital scholarship endowment campaign that will enable us to expand our impact by 50%. The campaign has been a tremendous success, but we still need to raise just over \$4.5 million by August 31, 2017. With that additional funding, Inner-City will secure scholarships each year for 2,500 students from their first day of Catholic school until their high school graduation. Success is in sight thanks to your extraordinary support.

There is no substitute for hard work, but every story of success includes an element of outside assistance. In the narrative of New York City Catholic schools, that element is you – caring people, despite the odds, taking a chance on our kids. On behalf of the thousands of students who are fortunate enough to have found your support, thank you for another successful year.
